## SECOND AMENDED PETITION FOR CLARIFICATION

Pursuant to Connecticut General Statutes § 7-471 and as a result of a detailed review and analysis of particular job descriptions and duties currently recognized in the AFSCME, Local 3144 bargaining unit, the City of New Haven believes that certain positions within said bargaining unit may be misclassified. Therefore, the City has filed this petition in order to determine whether said positions are properly included within the Local 3144 bargaining unit.

- 1. The City of New Haven ("City"), is a municipal employer within the meaning of the Municipal Employee Relations Act, Connecticut General Statutes § 7-467 et seq. ("Act"). Its address is 165 Church Street, New Haven, CT 06510.
- 2. Local 3144, AFSCME, Council 4 ("L. 3144") is an employee organization within the meaning of the Act. Its address is 444 East Main Street, New Britain, CT 06051.
- 3. That the City and L. 3144 are parties to a collective bargaining agreement ("L. 3144 CBA") having effective dates of July 1, 2010 through June 30, 2015.
- 4. That the Local 3144 bargaining unit encompasses supervisory and professional management job classifications and is supervisory and professional in nature.
- 5. That following a review and analysis of particular job descriptions and duties currently recognized in the L. 3144 bargaining unit, the City believes that the job titles contained in the attached Appendix A are misclassified, and should be removed from the Union. This Second Amended Complaint replaces and supercedes the Amended Petition filed on or about April 28, 2015.

#### REMEDIES REQUESTED

- 1. That the State Board of Labor Relations review the positions contained in <u>Appendix A</u> and clarify whether they are appropriately included within the Local 3144 bargaining unit.
- 2. Such other relief as the Board may deem just and proper.
